In pursuance of Head Quarters letter No. P-11/12/Agenda/06/2016-Revenue II dated 14.07.2025, SPREE has implemented all over India to expand the coverage of Employers and Employees under E.S.I. Act, 1948(As amended). However, as per directions received in V.C. dated 02.12.2025, the Director General has taken serious view of the poor performance so far. It is expected that we must complete the allotted target. Also, in V.C. it is clarified by the Hqrs. Office that Educational and Health Institutions are covered under Social Security Code, 2020 implemented w.e.f. 21.11.2025.

In view of the above, we are adopting target-based approach to complete the target. Accordingly, the following officials are being deployed to the field whereby it is expected to make wholehearted efforts so that number of units as per the list provided are persuaded to take coverage.

It may be noted that no document is to be sought at this stage as this is not a Survey but a positive drive to make the employers aware of the scheme and seek the coverage.

Therefore, all the officials are directed to visit the institutes / establishments in the list to expand the coverage under SPREE 2025 and submit the daily Report.
